GUARANTEE & INDEMNITY

In consideration of Speedimpex Australia Pty Limited ABN 52 138 437 984 (“Speedimpex”) agreeing to supply and/or continue supply

(the “Customer”) with goods and/or services from time to time or on a continuing basis:

- (1) I/We (individually and together) hereby agree with Speedimpex as follows:
 - (1.1) to be answerable and responsible to Speedimpex for the due payment by the Customer of all monies now and/or from time to time hereafter owing or unpaid to Speedimpex on any account whatsoever by the Customer, either directly or indirectly and either alone or jointly with any other person, firm and/or corporation including but not limited to any interest accruing on any monies owing or unpaid and any legal costs and disbursements on an indemnity basis incurred by Speedimpex in enforcing payment by the Customer of any such monies;
 - (1.2) to indemnify Speedimpex against all losses, damages, costs, charges and expenses which may suffer or incur Speedimpex as a result of any default by the Customer or me/us;
 - (1.3) that this Guarantee will constitute a continuing guarantee to Speedimpex for all monies which are now and/or may from time to time be owing or remain unpaid by the Customer;
 - (1.4) that I/We separately and together will not be entitled to invoke any defence, cross claim or set-off available to the Customer, and agree to pay the monies due under this Guarantee without any deduction whatsoever; and
 - (1.5) to be liable individually and together as principal debtors and not merely as Guarantors.
- (2) I/We acknowledge that:
 - (2.1) this Guarantee will not be avoided, released or affected by Speedimpex making any variation or alteration in the terms of any agreements made with or to be made with the Customer;
 - (2.2) any payment made to Speedimpex and later avoided by the application of any statutory provision will be deemed not to discharge my/our liability;
 - (2.3) all monies received by Speedimpex from the Customer or from any other person or corporation or from the realisation or enforcement of any security capable of being applied by Speedimpex in reduction of the indebtedness of the Customer will be regarded for all purposes as payments in gross without any right on my/our part to stand in Speedimpex’s place in respect of or to claim the benefit of ay monies so received and this Guarantee will apply to and secure any ultimate balance that remains due to Speedimpex;
 - (2.4) Speedimpex will not be under any obligations to take any steps or commence any proceedings against the Customer before enforcing any of its rights under this Guarantee and Indemnity; and
 - (2.5) this Guarantee is subject to the laws of New South Wales.
